Reduce rejection by:

- Submitting a 4506-T signed by taxpayer (spouse or authorized person) dated within 120 days;
- Use complete name and address as shown on filed returns in clear and legible print;
- Include audit trail document with **electronically signed 4506-T**;
- Include Power of Attorney document with **POA signed 4506-T**;
